To obtain a commercial certificate in an airplane under FAR Part 61 rules a pilot must have: 250 hours of flight time, 100 hours of which must be in powered aircraft, and 50 must be in airplanes. 100 hours of pilot-in-command time, 50 of which must be in airplanes. 50 hours of cross-country time, 10 of which must be in an airplane.
